With reference to the aforementioned subject and the correspondence exchanged till date, we, Adani Power (Jharkhand) Ltd. ("Employer") are pleased to issue this Letter of Award ("LOA") to you, M/s. Universal Test House ("Contractor") for your engagement in respect of the 2x800 MW Thermal Power Project at Godda Near Mali Gangta More Dist. Godda, Jharkhand for such scope of work and terms and conditions as are specified in **Annexure-I & II**.

This LOA is subject to the terms and conditions contained herein and in the tender documents, and the Contractor undertakes to perform its obligations in terms of this LOA in accordance with applicable law and the Employer's instructions. The terms of this LOA shall come into effect on the date of its execution and shall govern the understanding between the parties in respect of engagement of the Contractor for the Plant, until the earlier of: (i) expiry of Three (03) months from the date of this LOA; or (ii) execution of definitive agreement(s) between the Employer and the Contractor in respect thereof. This LOA shall stand automatically terminated upon the earlier of the expiry of said timeline hereinabove or execution of the definitive agreements.

Notwithstanding anything to the contrary, the Employer reserves the right to: (i) amend the provisions of this LOA; and/or (ii) terminate this LOA, in the event the Contractor fails to comply with the bid requirements, instructions of the Employer, or the basis on which this LOA has been issued is no longer commercially viable. The parties agree to keep all information contained in this LOA strictly confidential and shall not disclose the same to a third party, without the consent of the other party, except as may be required by the applicable law.

This LOA shall be governed by the laws of India. If any dispute arises between the parties in connection with or arising out of this LOA, the parties shall seek to resolve such dispute by referring the matter to an authorised representative of the Employer. Such representative shall provide his decisions within thirty (30) days of the referral of such dispute. Either party, if not in agreement with such representative's decision, may proceed to refer such dispute to the courts at Ahmedabad, Gujarat, India, and such courts shall have exclusive jurisdiction on all matters arising out of or relating to this LOA.

Annexure I

Terms and Conditions

1. Scope of Work

Scope of work broadly covers Providing services for Plate Load Test and Proctor Test at 2x800 MW Thermal Power Project site, village- Motia Mali, Gayeghat and adjacent villages, Dist-Godda, Jharkhand, India as per below details:

2. Effective Date

Effective date of the Contract shall be release date of this LOA.

3. Term

The Contract Period shall be Three (03) months from the Effective date of the Contract.

Contractor shall mobilize 100% of the manpower with required resources within 05 days from the date of this LOA.

4. Basic Price

Rs. 262,900/- (Rupees Two Lakh Sixty Two Thousand Nine Hundred Only) including all applicable taxes & duties except Goods and Services Tax (GST). Detailed Price Schedule shall be as per attached Annexure-II.

5. Taxes

5.1 Basic price shall be inclusive of all taxes & duties except GST which is exempted for the Services provided under this LOA.

5.2 Adani Power (Jharkhand) Limited has received approval vide letter no. FSEZ/LIC/A-1/2019/2205 dated 26.09.2019 issued by Development Commissioner, Falta SEZ, Ministry of Commerce, Government of India for setting up of Special Economic Zone (SEZ) Unit (stand-alone Power Plant) in Adani Power Jharkhand Limited SEZ in Godda district, Jharkhand for generation of power for export of electric energy. Pursuant to above, the Services provided for the Project would qualify for exemptions, concessions and drawback as per Section 26 of the SEZ Act, 2005.

6. Payment Terms

100% of the Basic Price shall be released on pro-rata basis within Fifteen (15) days against submission of monthly running account (RA) bills at Site upon completion of the month. The bill shall be paid based on the actual certified quantity and value passed by the Employer's Engineer In-Charge. Payment shall be made after receipt of clear invoice from Contractor and other required documents.

7. Other terms & Conditions:

- 7.1 Contractor shall provide Test reports as per latest IS standard.
- 7.2 If work will be done in phase wise manner, then again demobilization & mobilization charges shall be paid by Employer.
- 7.3 Contractor's manpower shall follow all safety standards, guidelines and job specific requirement (JSSR) at site. JSSR shall be as per attached Annexure-III
- 7.4 Contractor has to comply following IR/Statutory requirement at Employer's site.
- 7.5 Contractor shall provide all required PPEs like Safety Helmet, Safety shoes, Safety Jacket, ear plug, Safety goggles, Hand gloves, Leg guard, Hand sleeves etc. to their workmen as per Employer's approved standard.
- 7.6 Lodging, boarding of contractor's staff/workmen shall be arranged by the Contractor at their own cost.
